Administrative Law Advisory Committee (ALAC) End of the Year Report:

Tom Lisk thanked Judge Gardiner for directing the Code Commission members to the case, *Forbes v. Rapp*, where the VA Supreme Court articulated the doctrine of harmless error. Mr. Lisk presented the recommendation of ALAC to adopt the same standard for any appeal to the circuit court from any administrative agency final decision. Mr. Lisk explained that currently, the Virginia APA only allows the harmless error doctrine for procedural matters, but not in the case of substantive matters. ALAC found other states and the federal APA have adopted the harmless error doctrine for both procedural and substantive matters. Mr. Lisk then reported that ALAC recommended unanimously that the Virginia APA be amended to allow for the harmless error doctrine to all appeals.

More discussion followed with Judge Trumbo noting that he was concerned that were this recommendation from the Virginia Code Commission be put forward, it would contradict the tradition of the Code Commission refraining from making substantive legal changes to the Code.

Following more discussion, members determined that the Code Commission would not move forward with this recommendation from ALAC.

Public Notice Work Group Legislation:

Director Wade described the bill that resulted from the Public Notice Workgroup to the commission. Director Wade reported Delegate Williams had already indicated that he would be willing to carry the bill in the House and Senator Edwards offered to carry the bill in the Senate. There was no further discussion.

LexisNexis Report:

Holly Trice reported that the data from the Special Session that Lexis sent was much better than the July 1 data. There were minimal errors in the data; the agency just planned to work with Lexis to improve the "TOSA" (Table of Sections Affected) so that information that DLS did not need was not placed on the TOSA. Director Wade echoed that DLS was pleased with the most recent batch of data.

<u>Public comment, adjournment:</u> Senator Edwards opened the floor for public comment. There was no public comment.

<u>Adjourn:</u> Chair Edwards asked for a motion to adjourn the meeting. The motion was made, properly seconded, and a voice vote was conducted. The motion carried.

Virginia Code Commission Public Notice Work Group

Overview of Proposed 2023 Work Plan

Senate Bill 1151 and House Bill 2161, passed during the 2023 legislative session, provide for the Code Commission to reconvene the Public Notice Work Group to review requirements throughout the Code of Virginia for localities to provide public notice for intended actions, including business meetings, creation of taxation zones, proposed amendments to existing planning and zoning ordinances, and consideration of budgets. The Commission is required to submit a report to the Chairs of the House Committee on General Laws and the Senate Committee on General Laws and Technology summarizing the work and any recommendations of the work group by November 1, 2023.

I. Scope of Work Group Review and Recommendations

- **A.** Uniformity and Efficiency of Notices. Continue review of notices applicable to localities and determine the scope of review for regional and state entities. Recommendations will designate placement of selected notices in one of the following groups:
 - Group 3- Notice to run three successive weeks with the first notice appearing no more than 21 days before meeting or intended action.
 - Group 2- Notice to run two successive weeks with the first notice appearing no more than 14 days before meeting or intended action.
 - Group 1- Notice to run once at least seven days before meeting or intended action.
- **B. Information Required in Notices.** Continue the review of information required in notices relating to certain zoning and land use ordinances. The sub-work group will continue with its review of the descriptive summary required by § 15.2-2204 and the statement of general usage required by § 15.2-2285.
- C. Senate Bill 859 (2023). Review the legislation and make recommendations regarding publication of notice of a Request for Proposal by local public bodies.

II. Composition of Work Group

The 2023 work group will consist of representatives from the same stakeholder groups established in 2022. Additions will be made based on the scope adopted by the 2023 work group.



Wright **Thomas A. Lisk -** Tom Lisk focuses his practice on regulatory matters before agencies, boards, and commissions of the Commonwealth, including the State Corporation Commission. In addition, he is a registered lobbyist in Virginia, providing legislative representation of business interests and trade associations before the Virginia General Assembly since 1980.
