Subtitle III Suggested General Provisions

1. Imposing 3 year sunset to legislative collegial bodies.

Two possible approaches:

- An automatic 3 year sunset section
- Including a 3 year sunset in each bill draft (as it is in executive branch)

"After January 1, 2003, all bills creating an advisory board, council, commission, or other collegial body in the executive branch of state government shall contain a provision requiring the expiration of such body three years after its creation." (currently § 30-19.1:9. Duration of state boards and commissions.)

2. Legislative membership requirement for chair and vice-chair of collegial bodies.

"The chair and vice-chair of any collegial body shall be members of the General Assembly."

3. Voting equalization.

Modify language so that new commissions going forward shall have more legislative members than nonlegislative voting members. This is derived from a recommendation of the legislative guidelines published by the Joint Rules Committee and was discussed at the August 2024 meeting of the Code Commission.

• "For any legislative collegial bodies created on or after July 1, 2026, the number of legislative members shall exceed the number of nonlegislative citizen members and voting ex officio members."

Add a statement that the majority of legislators have to agree on a committee decision. This was discussed at the August 2024 meeting, but members weren't comfortable changing the makeup of existing committees/commissions.

- No recommendation of [the body] shall be adopted if a majority of legislative members votes against the recommendation.
- No recommendation of the Commission shall be adopted if a majority of the Senate members or a majority of the House members appointed to the Commission (i) vote against the recommendation and (ii) vote for the recommendation to fail notwithstanding the majority vote of the Commission.

4. <u>All other state agencies must assist bodies upon request.</u>

Some variation of this language is currently found in several different collegial body sections. To streamline the Subtitle, it could be helpful to instead impose this language as a blanket statement in General Provisions. This was briefly discussed at the August 2024 Code Commission meeting.

• "All agencies of the Commonwealth shall assist the Commission upon request."

5. <u>Removal authority.</u>

"Any nonlegislative citizen member appointed by either the Speaker of the House, the Senate Committee on Rules, or the Joint Rules Committee to any Authority, Board, Commission, Committee, or other deliberative body in the Commonwealth shall serve at the pleasure of such appointing authority. Any such member may be relieved of his appointment at any time, with or without cause." Item 1. M. of HB 30, 2024 session (and others in past).

6. <u>Only appointing authority is the Speaker, the Senate Committee on Rules, and the</u> <u>Joint Rules Committee.</u>

This is derived from a recommendation of the legislative guidelines published by the Joint Rules Committee and was discussed at the August 2024 meeting of the Code Commission.

• "All appointments for legislative studies shall be made by either the Speaker of the House, the Senate Committee on Rules, or the Joint Rules Committee."
